Driving on I-75 North:

- Take exit 169 (Arkwright Rd/Riverside Dr.)
- Take a left off of the exit onto Arkwright Rd.
- IMMEDIATELY work your way into the left turning lane.
- At the red light, take a left onto Riverside Dr.
- Take a right turn onto Holiday N. Drive, the first street to your right. You will see Krystal & Holiday Hotel. The office will sit near the top of the hill on your right next to Best Inn Suites - LOOK FOR THE GREEN SIGN and the office suites are underneath the PUBLIC LIBRARY sign.

Driving on I-75 South:

- Take exit 169 (Arkwright Rd/Riverside Dr.)
- Take a right off of the exit onto Arkwright Rd.
