Carroll	Six month terms beginning on the first Monday in March and September [1998]
Chatham	Three month terms beginning on the first Monday in March, June and December, and the first Tuesday after the first Monday in September [1997]
Chattooga	One month terms beginning on the second Monday of each month [1983]
Cherokee	Ten terms annually, beginning on the second Monday in January, February, March, April, June, August and December, and the third Monday in May, and the fourth Monday in September and October (NOTE: jury terms in January, March, June, August and November) [1974]
Clarke	Three month terms beginning on the third Monday in February, May, August and November [1895]
Clayton	Three month terms beginning on the first Monday in February, May, August and November [1980]
Clinch	One month terms beginning on the first Monday of each month (NOTE: jury terms in January, April, July and October) [1943]
Cobb	Two month terms beginning on the first Monday in January, March, May, July, September and November [1979]

Coffee	One month terms beginning on the fourth Monday of each month (NOTE: jury terms in February, May, August and November) [1929]
Colquitt	One month terms beginning on the first Monday of each month (NOTE: jury terms in January, April, July and October) [1976]
Coweta	Three month terms beginning on the third Monday in January, April, July and October [1889]
Decatur	One month terms beginning on the third Monday of each month [1983]
DeKalb	Three month terms beginning the first Mondays of January, April, July, and October. [1983]
Dougherty	One month terms beginning on the first Monday of each month [1983]
Douglas	Six month terms beginning on the second Mondays of April and October [1999]
Early	One month terms beginning on the third Monday of each month [1937]
Effingham	One month terms beginning on the second Monday of each month (NOTE: jury terms in March, June, September and December) [1961]
Elbert	Three month terms beginning on the second Monday in March, May, September and November [1985]
Emanuel	Three month terms beginning on the second Monday in March, June, September and December [1964]
Evans	Three month terms beginning on the third Monday in February, May, August and November [1922]

Grady	Three month terms beginning on the second Monday in January, April, July and October [1949]
Gwinnett	Two month terms of court beginning on the first Monday in January, March, May, July, and November, and second Monday in September [1981]
Habersham	Three month terms beginning on the first Monday in January, April, July and October [1987]
Hall	Two month terms of court beginning on the first Monday in May and November, and second Monday in January, March, July and September [1987]
Henry	Three month terms beginning on the second Monday in January, April, July and October [1998]
Houston	Two month terms beginning on the third Monday in January, March, May, July, September and November [1981]
Jackson	Two month terms beginning on the third Monday in January, March, May, July, September and November [1988]

Jeff Davis	Three terms annually beginning on the second Monday in January, May and September [1984]
Jefferson	One month terms beginning on the third Monday (NOTE: jury terms in January, April, July and October) [1964]
Jenkins	One month terms beginning on the fourth Monday (NOTE: jury terms in January, April, July and October) [1988]
Liberty	One month terms beginning on the third Monday (NOTE: jury terms in January, April, July and October) [1917]
Long	One month terms beginning on the second Monday, except the fourth Monday in September (NOTE: jury terms in February, June and September) [1931]
Lowndes	Three month terms beginning on the second Monday in January, April, July and October [1918]
McIntosh	Two month terms beginning on the second Monday in January, March, May, July, September and November [1993]
Miller	Three month terms beginning on the second Monday in March, June, September and December [1935]
Mitchell	Three month terms beginning on the first Monday in February, May, August and November [1905]
Muscogee	Two month terms beginning on the first Monday in January, March, May, July, September and November [1952]
Pierce	Three month terms beginning on the fourth Monday in February, August and November, and third Monday in May [1927]
Putnam	Six month terms beginning on the second Monday in January and July [1997]
Richmond	Two month terms beginning on the third Monday in February, April, June, August, October and December
Rockdale	Three month terms beginning on the first Monday in January, April, July and October [1988]
Screven	Two month terms beginning on the second Monday in February, June, August, October and December, and fourth Monday in April [1953]
Spalding	Three month terms beginning on the first Monday in March, May, August and November (NOTE: criminal jury trials the 1 st week of March, May, August and November; non-jury weekly on Tuesday except in jury trial weeks) [2002]
Stephens	Six month terms beginning on the fourth Monday in February and August [1999]
Sumter	Three month terms beginning on the third Monday in March, June and September and the second Monday in January [1993]
Tattnall	Three month terms beginning on the second Monday in March, June and September and December [1923]
Thomas	Three month terms beginning on the first Monday in March, June and September and December [1905]
Tift	Three month terms beginning on the first Monday in February, May, August and November [1971]

Toombs	One month terms beginning on the second Monday of each month (NOTE: jury terms on the fourth Monday in January, April, July and October) [1931]
Treutlen	Three month terms beginning on the second Monday in January, April, July and October [1969]
Troup	Three month terms beginning on the first Monday in March, June and December, and the first Tuesday in September [1962]
Turner	Three month terms beginning on the second and third Mondays in January and July, and the second Monday in April and October [2002]
Walker	Three month terms beginning on the second Monday in March, June, September and December [1957]
Ware	Three month terms beginning on the third Monday in March, June, September and December [1911]
Washington	One month terms beginning on the fourth Monday of each month (NOTE: jury terms as needed) [1901]
Wayne	Six month terms beginning on the fourth Monday in January and July [1997]
Worth	One month terms beginning on the second Monday of each month (NOTE: jury terms in March, June, September and December) [1916]
